Scope of this Privacy Policy

This Privacy Policy covers CampusGuard's treatment of personally identifiable information collected from users of the CampusGuard Portal, as well as information that we acquire from your institution to offer you access to the CampusGuard Portal.

This Policy does not apply to the practices of companies that CampusGuard does not own or control, or to people that CampusGuard does not employ or manage.

Information Collection and Use

The personally identifiable information we acquire from you varies according to the way in which your institution is using our CampusGuard Portal. We may also collect information about your computer and your visits to this website such as your IP address, geographical location, browser type, referral source, length of visit and number of page views. Information Security

We work to protect the security of your information during transmission by using Secure Sockets Layer (SSL) software, which encrypts information you input. We store information gathered on secure computers located in a locked data center. We use firewalls, intrusion detection systems, and database level encryption technology to prevent our computers from being accessed by unauthorized persons.
